APPLICATIONS & ELIGIBILITY—Application for booth space is made on the printed form provided by CollectTECH19 and must contain the information requested. Exhibits of equipment, products, or services must enhance the purposes of CollectTECH19 conference. Any producer or supplier whose goals and purposes do not conflict with those of CollectTECH19 may apply. CollectTECH19 reserves the right to refuse any applicant.

ASSIGNMENT OF SPACE—Booth space will be assigned by CollectTECH19. Management reserves the right to assign, rearrange and relocate booths.

BOOTHS—One retractable banner per bay, maximum size 33” x 79” high. Banner will be placed in the conference area on Monday, Opening Reception Monday evening, TopGolf bay on Tuesday and the Breakfast & TECHtalk location on Wednesday morning.

DEFAULT OCCUPANCY—Any exhibitor failing to occupy space is not relieved of the obligation to pay for such space. CollectTECH19 shall have the right to use such space as it sees fit.

PERSONNEL—All booth personnel are required to confine their activities within the exhibitor’s booth space.
